## Schedule of charges from 1 July 2026.

### Prices explained

Depending on the electricity plan you choose, you will see a combination of the following charges as applicable.

<b>Supply charge</b>	A fixed price per day.
<b>Usage charge</b>	A price per unit of usage (measured in kilowatt hours (kWh)) for the amount of electricity you use at your premises.
<b>Demand charge</b>	A charge for the maximum demand placed on the electricity network at your premises during the defined time period and measured in kW or kVA depending on the plan.

### Distributor service charges

The following services will be charged as a pass through from the relevant electricity distributor (Essential Energy or Endeavour Energy). The charges listed below are the most common services requested by ActewAGL customers in NSW. Charges for services provided by the electricity distributor (in addition to the ones listed below) will also be passed through to you. - Special meter read
- Meter test – business hours
- Supply of conveyancing information
- Controlled load conversions
- Disconnections site visit (only) business hours payment received
- Disconnection/de-energisation at meter box business hours
- Disconnection/de-energisation at pole top/pillar box business hours
- Rectification of illegal connection
- Reconnection outside business hours
- Site establishment per NMI.

## Comparison price set by the Australian Energy Regulator (AER)

### What do these regulated prices for standard contracts mean for the average customer?

To enable customers to compare electricity costs electricity retailers are required to tell residential and small business customers how electricity plan prices compare to the comparison price set by the AER. The comparison price is a calculation of what a representative customer on a standing offer would pay for their electricity per year. A representative customer is someone who uses the average annual amount of electricity for a household or small business as determined by the AER, which varies by distribution area. Your electricity costs may be significantly different depending on your own actual usage.
